4. The **Quantity-Dependent Fee** applies to the volume of certified RFNBO-compliant output declared by the System User. At the beginning of each year, the System User must provide an estimate of the expected production volume, which will be billed upfront at a discounted rate (10% lower than the standard fee). At the end of the year, an adjustment will be made based on the actual production, with any additional volumes charged at the standard rate. Declarations are subject to annual verification during recertification.
5. A **Minimum Fee** of 250 € applies if no sustainable output is declared or if the declared output is below this amount.
